 - a City and Guilds Centre approved for the delivery and assessment of 3667, 3666 or 3662 series qualifications;
- or
 - willing to undergo and successfully complete an initial and subsequent annual audit by FIA Qualification Scheme Directorate staff.

By completing this Application Form, the applicant is agreeing to:

- undertake to comply with the FIA Qualification Scheme requirements;
- accept FIA arbitration in the event of any dispute with a learner;
- · accept the authority of the FIA to inspect training facilities and materials as the FIA sees fit;
- accept the right of the FIA to withdraw Approved Training Provider status should the applicant be deemed not to be working
 in the spirit of the FIA Qualification Scheme;
- provide a completed Renewal Application Form every 12 months or as requested by the FIA.
